Declaration of Abdulaziz Al Shammari

(Typed Version)

I declare under penalty of perjury of the laws of the United States that the following is true and correct:

1. I am a citizen of the State of Kuwait, am over eighteen years of age and have never been charged or convicted of any crime.
2. I have been incarcerated at Guantanamo for more than three and a half years. I have never fought against the United States and I am totally innocent of any wrongdoing.
3. Since August 4, 2005, I have refused voluntarily to eat, drink or accept medicine.
4. After about 3 weeks, I collapsed on the floor and couldn't stand up, and they put me on an IV.
5. At the beginning of September, guards took me to the hospital, they put me on an orange board on my back for 6 hours with my arms strapped on my side. They said we will put a feeding tube in you. I refused. They strapped me down on the bed and forced tube through my nose. Twice the tube came out through my mouth. I spit blood.
6. The doctors told me that they had a court order authorizing them to do this. My attorney informed me that there was no court order. I then confronted the doctors and told them they had lied about having a court order.

7. After that I tore the tubes out. The guards then came and took me from my cell to the clinic. They tied me up so that I could not move, and then forced the tubes back in me. My right foot was hurt when they did this. It is in a cast and I need to use a walker to walk.
8. I have continued to lose weight despite the force feeding. I have attached charts I took from the clinic showing that my weight has continued to drop and that I have gone from 200 pounds to 132 pounds. It is even lower than that now, but I no longer will stand on the scale to allow them to weigh me.
9. Since they have been force feeding me here, I have continuously experienced nausea, diarrhea and vomiting.
10. To monitor my health, a nurse comes to my cell once a week to weigh me, take my blood pressure and take a blood sample. As mentioned, I will no longer stand on the scale; this is one thing they cannot force me to do. They do force me to give a blood sample. The blood samples are taken by a nurse or corpsman and they are inexperienced, and it is painful.
11. At the beginning, when they force fed me they used a tube with a size called 12 French. Then, after 2 or 3 days, they pulled it out and forced in a much larger tube with a size called 18 French. Then they would take it out after the feeding and then force it back in again before the next feeding. Sometimes they would reinsert the old tube without sterilizing it. When I complained, the doctor told me they did not have adequate medical equipment.

12. For the last approximately three weeks, they have used smaller tubes and they do not take it out after each feeding and reinsert it before the next.
13. I understand now that it is useless for me to resist, and the guards will only tie me up and will be forced no matter what I want.
14. I believe that now there are between 20 and 25 people being force fed at Guantanamo.

7. After that I tore the tubes out. The guards then came and took me from my cell to the clinic. They tied me up so that I could not move, and they forced the tubes back in me. My right foot was hurt when they did this. It is in a cast cast and I need to use a walker to walk.

I have attached charts I took from the clinic showing that my weight has continued to drop and that I have gone from 200 pounds to 132 pounds. It is even lower than that now, but I no longer will stand on the scale to allow them to weigh me.

9. Since they have been force feeding me here, I have continuously experienced ~~nausea~~ nausea, diarrhea and vomiting.
10. To monitor my health, a nurse comes to my cell once a week to weigh me, take my blood pressure and take a blood sample. As mentioned I will no longer stand on the scale; this is one thing they cannot force me to do. They do force me to give a blood sample. The blood samples are taken by a nurse or corpsman and they are inexperienced, and it is painful.
11. At the beginning, when they force fed me they used a tube with size called 12 French. Then, after 2 or 3 days they pulled it out and forced in a much larger tube with

a size called 18 French. Then they would take it out after the feeding and then force it back in again before the next feeding. Sometimes they would reinsert the old tube without sterilizing it. When I complained, the doctor told me they didn't have adequate medical equip ment.

12. For the last approximately three weeks, they have used smaller tubes and they do not take it out after each feeding and reinsert it before the next.

13. I understand now that it is unless for me to resist, and the guards will only tie me up and will be forced no matter what I want.
