**ORDER SCHEDULING OCTOBER 20, 2004 HEARING
ON PROTECTIVE ORDER ISSUES**

On this date, David H. Remes, counsel for certain petitioners, and Terry M. Henry, counsel for respondents, telephoned chambers to request a hearing on pending issues relating to a proposed protective order in these coordinated cases. Upon consideration of the request, it is hereby

ORDERED that there shall be a hearing on protective order issues on Wednesday, October 20, 2004 at 3:30 p.m. in Courtroom 2. It is further

ORDERED that counsel shall file with the Court on or before Tuesday, October 19, 2004 at 4:00 p.m. a proposed protective order with comments clearly indicating the language upon which counsel were able to agree and the issues which remain in conflict. For those issues upon which counsel were unable to agree, the submission shall contain a brief summary of the reasons for the conflicting positions. Counsel shall deliver a copy of the filing to Christine E. Gunning, Security Specialist on the Justice Department’s Security and Emergency Planning Staff, at the time the filing is made with the Court. It is further

ORDERED that counsel for petitioners shall make every effort to have one attorney represent their positions at the hearing. In the event of a disagreement among the various counsel for the petitioners on a specific protective order issue, the Court will allow more than one attorney to address that issue.

This Order is being delivered electronically and only to those counsel of record who have registered to receive electronic service via the CM/ECF system.
