**ORDER SETTING DEADLINE FOR SUBMISSIONS IN RESPONSE
TO MOTION FOR AN ORDER REQUIRING PARTIES TO ABIDE
BY PROPOSED PROCEDURES FOR COUNSEL ACCESS**

On October 22, 2004, petitioners Moazzam Begg and Feroz Ali Abbasi filed in civil action number 04-CV-1137 (RMC) a motion for an order implementing proposed counsel access procedures. In the accompanying memorandum of points and authorities, counsel for petitioners represented that they “have conferred by telephone with counsel for Respondents and Respondents ‘are not in a position to express a position on [Petitioners’] motion at this time.’” Memorandum at 4 n. 2.

It is the Court’s intention to issue uniform counsel access procedures in all of these coordinated cases except to the extent that such procedures have already been issued by Judge Colleen Kollar-Kotelly with respect to petitioners Mohammed Ahmed al Kandari, Fawzi Khalid Abdullah Fahad al Odah, and Khalid Abdullah Mishal al Mutairi in Al Odah v. United States, 02-CV-0828 (CKK). To ensure the greatest possible uniformity of counsel access procedures applicable to these coordinated cases and to allow a prompt resolution of access issues in

conjunction with the protective order matters that have already been briefed and argued, it is hereby

ORDERED that should counsel for respondents or counsel for any petitioner in these coordinated cases wish to oppose, supplement, concur with, or otherwise comment on the proposed procedures set forth in the Motion for an Order Requiring Parties to Abide by Proposed Procedures for Counsel Access and Request for Expedition, filed on October 22, 2004 in Begg v. Bush, 04-CV-1137, counsel must do so in a written submission filed with the Court no later than 12:00 noon on November 4, 2004.

IT IS SO ORDERED.
