JOINT NOTICE OF PROPOSED AGENDA FOR STATUS HEARING

Petitioners and Respondents respectfully submit this Joint Notice of Proposed Agenda for the status hearing scheduled in the above-captioned cases for April 22, 2009. Petitioners and Respondents state as follows:

MOTIONS TO BE ARGUED AT THE STATUS HEARING

1. On March 13, 2009, Petitioner Abdul Al Qader Ahmed Hussain (ISN 690) filed a motion for discovery or, in the alternative, to compel in Case No. 05-2104, with the Court Security

Officer. On March 27, 2009, the Government filed an opposition with the Court Security Officer. On April 10, 2009, Petitioner Hussain filed a reply with the Court Security Officer. Counsel for Petitioner and the Government anticipate that the motion can be argued in one hour. The hearing must be held in closed session after the status hearing.

2. The Government has filed motions to stay proceedings pending counsel providing evidence of direct authorization to represent petitioners in the following cases:

a. Abdul Rahman al-Qyati (ISN 461) and Saad Masir Mukbl al-Azan (ISN 575), in Case No. 08-2019. The Government's motion to stay was filed March 27, 2009 (Dkt. No. 70). On April 17, 2009, Petitioners al-Qyati and al-Azan filed an opposition (Dkt. No. 83).

b. Jamil Ahmad Saeed (ISN 728), in Case No. 05-2386. The Government's motion to stay was filed on March 20, 2009 (Dkt. No. 1091). On April 1, 2009, Petitioner Saeed filed an opposition to the Government's motion (Dkt. No. 1107). On April 8, 2009, the Government filed reply to Petitioner Saeed's opposition (Dkt. No. 1132).

The hearings on the motions to stay can be held in open session.

OTHER PENDING MOTIONS

3. On March 25, 2009, Petitioner Nadir Omar Abdullah Bin Sa'adoun Als'ary (ISN 30) filed a motion for discovery with the Court Security Officer, in Case No. 05-2386. On April 8, 2009, the Government filed on opposition with the Court Security Officer. Petitioner Als'ary has filed a reply. Counsel for Petitioner Als'ary is available to argue the motion on the following dates: May 1, 8, 11, 12, or 13. Counsel for the Government is available on those dates.

4. On March 19, 2009, Petitioner Maher El-Falesteny (ISN 519) filed on his own

behalf and on behalf of other petitioners a supplemental memorandum in support of his motion for a preliminary injunction to compel compliance with the Geneva Conventions (Dkt. No. 1084). The Government filed an opposition on April 9 (Dkt. No. 1137), and petitioners filed a reply on April 16 (Dkt. No. 1146). The motion is scheduled for argument on April 27, 2009.

5. On April 14, 2009, Petitioner Oybek Jamoldinivich Jabbarov (ISN 452) filed a motion for discovery with the Court Security Officer, in Case No. 05-2386. On April 15, 2009, the Government filed an unopposed motion for an extension of time to file an opposition (Dkt. No. 1145).
