1. O2 [redacted] The purpose of this memorandum is to report an incident of possible prisoner/detainee abuse suffered by ISN O2 [redacted] - 00551, Fouad Mahoud Hasan AL RABIA
2. O2 [redacted] On 01Sep04, MAJ O6 [redacted], USAF O1, O6 [redacted]; Office of Administrative Review for Detained Enemy Combatants (OARDEC), appraised Reporting Agent of a situation, in which a detained person alleged he has been repeatedly victimized by United States Forces (NFI) since his initial capture in Afghanistan, and subsequent transfer to U.S. Naval Base, Guantanamo Bay, Cuba.
3. O2 [redacted] MAJ O6 [redacted] related that on 28Aug04, during a personal interview of AL RABIA in preparation for a Combatant Status Review Tribunal, AL RABIA levied a myriad of complaints against Joint Task Force Guantanamo Bay, Cuba, regarding mistreatment endured during his confinement at O1, O2 [redacted]. AL RABIA's statements regarding his mistreatment are documented below:
 - O2 [redacted] Detainees are supposed to get recreation/exercise 3 times a week, they are lucky to get recreation/exercise 3 times a month. Most recently they went 10 days between recreation/exercise periods.
 - O2 [redacted] The floors are cleaned with concentrated floor cleaner that is used undiluted, he claims this causes breathing problems with detainees and causes them to choke and cough.
 - O2 [redacted] They often go up to 1 month without changing their clothes, he claims they should be changed once a week
 - O2 [redacted] People are often kept in isolation for up to 3 months. He stated that if this continues, it will start riots. He claimed people have threatened to go on hunger strikes to death
 - O2 [redacted] Guards are skipping medications for some people
 - O2 [redacted] They don't always play the call for prayer

• O2 Claims guards gave a hypodermic drug (shot) to a detainee that was very upset to calm him down. The detainee was very young (17), he is concerned the detainee might become addicted to drugs.

4. O2 Moreover, MAJ O6 also related that during a follow up interview of AL RABIA, conducted on 30Aug04, AL RABIA made several comments wherein he alleged he was tortured after being placed under United States control, specifically:

• O2 He claimed he was repeatedly hit in the face and had his jaw broken (in Afghanistan)

• O2 He was kicked with boots and was whipped with a chain, claims he has an indentation in his chest (sternum) as a result of the injuries incurred (in Afghanistan)

• O2 He also claimed he was chained to a chair, drenched in water and put into a room that was 55 deg F (here at GTMO)

SUMMARY: [REDACTED] PROBABLY IN LATE 2001, ABU ABDULLAH AL-KUWAITI ISSUED OR RELAYED NON-SPECIFIC THREATS AGAINST THE UNITED STATES. IN ADDITION, THE DOCUMENT MENTIONED OSAMA BIN LADEN AND [REDACTED] IN CONNECTION WITH UNIDENTIFIED OPERATIONS, POSSIBLY IN AFGHANISTAN, AND CONTAINED NAMES/ALIASES OF POSSIBLE AL-QAEDA PERSONNEL. ENCLOSURE.

TEXT: 1. [REDACTED] INTRODUCTION. THE ORIGINAL DOCUMENT, CONSISTING OF 14 PAGES IN ARABIC, WAS RECOVERED FROM A TALIBAN OR AL-QAEDA CAVE/STRONGHOLD IN THE TORA BORA (CNA) AREA OF AFGHANISTAN (AF). PROBABLY IN LATE 2001, ABU ABDULLAH AL-KUWAITI (THE KUWAITI) ISSUED OR RELAYED NON-SPECIFIC THREATS AGAINST THE UNITED STATES. IN ADDITION, THE DOCUMENT CONTAINED

FRAGMENTARY INFORMATION OF OPERATIONAL NATURE, TO INCLUDE POSSIBLE AL-QAEDA/TALIBAN OPERATIONS IN NORTH AFGHANISTAN IN LATE 2001. SPECIFICALLY, [REDACTED] INFORMED [REDACTED] OF HIS READINESS (NFI), AND OF A LIST OF POSSIBLE AL-QAEDA OR TALIBAN PERSONNEL.






